

## SERVICE TERMS – DOMAIN PROXY SERVICE

These Service Terms – Domain Proxy (**Domain Proxy Service Terms**) are between the Com Laude Group entity identified in the Order Form (and, where applicable, its affiliate(s)) (**we, our, us** and **Com Laude**) and the client entity named in the Order Form (**you, your, Client**).

1. **Definitions.** Where capitalised terms are used but not defined below, they shall carry the meaning given to them in your Order Form or General Terms.
2. **Application.** These Domain Proxy Service Terms shall apply in relation to any domain name of yours that is registered in the name of DLL.
3. **DLL.** The domain proxy services will be provided via DLL, a non-trading company established with the sole purpose and function of holding domain names on behalf of Com Laude's clients. The identity of the DLL proxy entity will be displayed on your domain registration as either:
  - (a) **Domain Licenses Limited**, a company registered in England and Wales with company number 05599675 whose registered office is at 28–30 Little Russell St, London WC1A 2HN; or
  - (b) another non-trading company established by Com Laude for the same purposes, as may be established from time to time.
4. **Orders.** You may place an order for Com Laude to register a domain in the name of its proxy and, if accepted, Com Laude will name DLL as the registrant.
5. **Domain-related requests.** DLL will comply with all requests from you or Com Laude in relation to changes to the details recorded at the registries in relation to your domain name including renewal, cancellation, contact details, modifications, assignments and technical details. You will pay the corresponding charges as set out in your Order Form.
6. **Indemnity.** You shall indemnify and keep fully indemnified DLL and Com Laude from and against all claims, actions, proceedings, demands, costs (including legal costs of DLL and Com Laude on a solicitor-client basis), awards and damages arising directly or indirectly as a result of any terms of these Domain Proxy Service Terms or as a result of DLL being named as registrant in relation to your domain name. This includes any claim of infringement of trademark or other intellectual or industrial property rights whether such a claim is pursued through the courts, a dispute resolution service or through any other means.
7. **Third-party disputes.** You accept the obligation to defend and fund any ownership or other dispute with third parties in relation to your domain name, and DLL and Com Laude agree to cooperate as necessary provided that you are responsible for all costs involved.
8. **Beneficial ownership.** DLL acknowledges that you are the beneficial owner of the domain name(s) registered in its name and at no time now or in the future will DLL make any claim to ownership of the domain name(s) other than agreeing to be named as the registrant.
9. **Escrow of registration data.** You acknowledge that registered name holder (registrant) and other registration data is routinely escrowed by Com Laude to an external escrow agent as mandated and authorised by ICANN, including if you use a proxy or privacy service with us. This information may only be accessed by ICANN if a registrar loses its ICANN-accreditation or ceases business.
